

# Welcome to Term 2 – Principal Welcome

Dear parents/carers,

It is with great excitement that we commence Term 2. Our staff have missed each and every student and we are thrilled that a pathway back to the classroom has been communicated by the Department of Education.

Attached to this letter you will find a document titled A Managed Return to School: Guidelines for Families. This guide sets a roadmap for the various steps which will occur in 'returning to normal'.

We are currently operating in **Phase 0**, meaning that the school is open but only for families who need it. Families are encouraged to keep their children at home wherever possible however no student will be turned away.

Phase 0 will continue this week and next (Week 1 and Week 2 of Term 2).

On Monday 11 May, every public school in NSW will move to **Phase 1** which signals a staggered return to school for students. In **Phase 1**, students are asked to attend school for face to face teaching and learning for **one day** each week, and learn from home for the remainder of the week. Information over the page is provided about how the school will manage **Phase 1**.

Later in the term we hope to move into Phase 2 where students will attend school for two days each week. No timeline has been placed on this. The Department of Education will be informed by medical advice.

The Remote Learning Plans for Week 1 of Term 2 are now on the school website and can be accessed here.

Another terrific resource which I strongly urge you to peruse is the <u>Department of Education's Learning from Home</u> <u>Hub</u>. Here you will find resources and guides to support students and parents.

I am aware of some difficulties both parents and our **Out of School Hours Care** provider, Wesley Mission, are experiencing in relation to the care facility. If your child is booked into OOSHC but is not going to attend and you are yet to let the centre know, please do so now so that others who need the care may be able to access it.

We are here to help and support. If you have any queries or need some guidance, do not hesitate to contact your child's teacher/s, the school office, Stage Assistant Principal or me directly. It will no doubt be a challenging term, but I am confident that together we can ensure that high quality teaching and learning continues. #IBelongAtNK!

## North Kellyville Public School: Phase 1 Implementation Guide From Monday 11 May 2020

Dear parents/carers,

On Monday 11 May, North Kellyville Public School will move to Phase 1 of the Department of Education's Managed Return to School guidelines. In this phase students are asked to attend school one day per week for face to face teaching and learning. The remaining four days each week will maintain the remote learning strategy currently in place. We will work towards having no more than 25% of students and a reduced amount of staff members on site each day.

Determining how the school would implement this phase has been challenging. We are seeking the support from our student and parent community in order to make Phase 1 of returning to school a success.

Please review the schedule on the following page which indicates the day each class should attend school. We ask that where possible you adhere to the schedule. We also recognise that parents with more than one child might prefer to send their children on the same day as each other. This is okay and encouraged. If you would like to request a change of day so that siblings can attend on the same day, **you must email** <u>northkellyville-</u><u>p.school@det.nsw.edu.au</u> and make the request in writing. Our staff will confirm arrangements for your child.

When not at school, students are asked to continue working at home. As it was last term, Google Classroom will be the main point of information for students and parents. Remote Learning Plans in Phase 1 will include 4-days of work each week. They will be posted on our school website, within Google Classrooms, and be available for collection (for those who want a hard copy). **Hard copies will be available for collection from Friday 8 May** at the school office.

Students who attend school for more than one day each week in **Phase 1** will be supervised in a separate group on days other than the day that their class is learning face to face. During this time they will be supported to complete Remote Learning Plans.

We know that these arrangements will not suit everybody and will work with families where necessary to support personal circumstances. Thank you for your support and understanding.
